Major Exposure Reduction Activities

Klamath County School District developed a Healthy and Safe Schools Plan as per SB 1062 which was implemented in 2019. The plan outlines the plan and timeline for Klamath County School District to test and respond to lead in paint, asbestos, radon, integrated pest management, carbon monoxide, and lead in water. The following is a summary of the Klamath County School District Health and Safe Schools Plan and activities which occurred under the plan during 2023-24 school year.

Water Testing

Beginning with the 2023-24 school year, samples were taken from designated facilities at all sources where students, staff, or the community could retrieve water for drinking. This included all required drinking fountains and sinks. Locations where samples tested at or above the action level of 15 ppb are listed below with associated corrective action taken:

Asbestos Testing

Every 6-months, KCSD staff checks locations of identified asbestos. Inspections confirm areas have not been disturbed and/or asbestos is still contained. Inspections are logged and results noted. Any concerns or disruption to an area are addressed as per the KCSD Asbestos plan.

Every 3-years, KCSD contracts with a 3rd party to complete comprehensive asbestos inspections and complete any corrective action as necessary across KCSD.

During construction projects, where asbestos is present, a 3rd party is hired to abate/contain/remove/dispose any asbestos.
